SUPERINTENDENT'S REPORT

Bruce Dewar from Schneider, Larche, Haapala & Company reviewed the 2020 Financial Audit via telephone with the Board and those in attendance. Alycia Kaiser, along with Emmalyn Braun and Kelsey Muth, presented the Board with The Grind financials as well as their Education Award recipients. MPC athletic awards were announced. Howard accepted the resignation of Emily Weber as an elementary teacher effective March 26, 2021. Interim lead teachers at Emerald are Jill Richey and Elisha Dougherty, along with Howard. The Emerald Student Leadership Team will be putting a time capsule for the fifth grade on Emerald property to be opened when they graduate. Teacher tenure rules were reviewed. A health update was presented. It was announced that MSU signed a contract to extend their lease for an additional year.
