Howard acknowledged resignations from EduStaff employees Kristi Steinhour as an educational aide and Crystal Snyder as an assistant cook, as well as the retirement of Victoria Cartwright as a bus driver and Valerie Hartman as the head cook. The Kiwanis Club recently donated \$3,711.06 to our teachers through the School Tools program. Howard informed the Board that his Pioneer Tribune article last week was to try to recruit substitute teachers and educational aides. A legislative update was presented, including a bill that could provide some pupil accounting flexibility. The E4 Project report was received from Trisha McEvers for October, 2020 thru September, 2021.
